**ARTICLES OF ORGANIZATION
OF
DATA DESIGN ASSOCIATES, L.C.**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of this Limited Liability Company is Data Design Associates, L.C.

ARTICLE VII - MANAGEMENT


The management of Data Design Associates, L.C. is reserved to the members. The following person will initially be the managing member:


