- (d) file Articles of Amendment and these Minutes of Meeting of Members with the Florida Secretary of State.

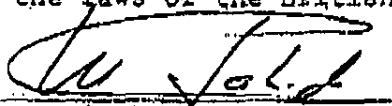

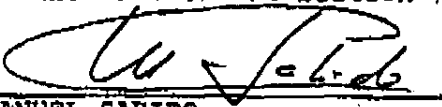
