ARTICLES OF ORGANIZATION OF CSCM, L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - Name

The name of the limited liability company (the "Limited Liability Company") is:

These regulations may contain any provisions for the regulation and management of the business and affairs of the Limited Liability Company not
