ARTICLE I – NAME

The name of the Limited Liability Company shall be:

ARTICLE II – DURATION

ARTICLE VI – MANAGEMENT PROVISIONS

Subject to the provisions and requirements of the laws of the state of Florida, the following provisions are adopted for the management of the Limited Liability Company and for the conduct of affairs of the Limited Liability Company, and for defining, limiting and regulating the powers of the Limited Liability Company and its members:

- a) The books of the Limited Liability Company may be kept outside of the state of Florida at such place or places as may from time to time be designated by the members of the Limited Liability Company.
- b) The business of the Limited Liability Corporation shall be managed by its managing members; and the managing members shall have the power to exercise all the powers of the Limited Liability Company, including (but without limiting the generality hereof) the power to create mortgages upon the whole or any part of property of the Limited Liability Corporation, real or personal, without any action of or by the other members, except as otherwise provided by statutes or by the Bylaws.
- c) An increase in the number of managing members shall be deemed to create a vacancy or vacancies in the managing members, to be filled in the manner provided in the Bylaws. Any managing member may be removed at any time, in such manner as shall be provided in the Bylaws.
- d) The managing members shall have the power to make or alter Bylaws, subject to such restrictions upon the exercise of such power as may be imposed by the other members in any bylaws adopted by them from time to time.
- e) The managing members shall have the power, in its discretion, to fix, determine and vary, from time to time, the amount to be retained as surplus and the amount or amounts to be set apart out of any of the funds of the Limited Liability Company available for dividends as working capital or a reserve or reserves for any proper purpose, and to abolish any such reserve in the manner in which it was created.
- f) The managing members shall have the power, in its discretion, from time to time, to determine whether and to what extent and at what times and places and under what conditions and regulations the books and accounts of the Limited Liability Company, or any of them, other than the stock ledger, shall be open to the inspection of members; and no member shall have any right to inspect any account or book or document of the Limited Liability Company, except as conferred by law or authorized by resolution of the members.
- g) Upon any sale, exchange or other disposal of the property and/or assets of the Limited Liability Company, payment therefor may be made either to the Limited Liability Company or directly to the members in proportion to their interests, upon


their surrender of their respective stock certificates, or otherwise, as the managing members may determine.

- h) In case the Limited Liability Company shall enter into any contract or transact any business with one or more of its members, or with any corporation or association of which any member is a stockholder, director or officer, such contract or transaction shall not be invalidated or in any way affected by the fact that such member has or may have an interest therein which is or might be adverse to the interests of the Limited Liability Company, even though the vote of such member might have been necessary to obligate the Limited Liability Company upon such contract or transaction; provided, that the fact of such interest shall have been disclosed to the other members of the Limited Liability Company, as the case may be, acting upon or with reference to such contract or transaction.
- i) The Limited Liability Company reserves the right to amend, alter, change, add to or repel any provision contained in these Articles of Organization in the manner now or hereafter prescribed by statute; and all rights herein conferred are granted subject to this reservation.

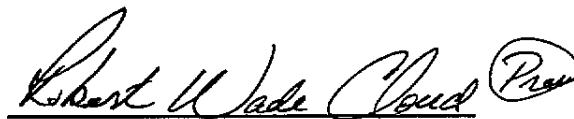
