**ARTICLES OF ORGANIZATION
OF
GREEN DREAMS, L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes (the "Act"), hereby make, acknowledge and file the following Articles of Organization.

**ARTICLE I
Name**

The name of the limited liability company is GREEN DREAMS, L.C. (the "Company"). The principal place of business of the Company in Florida shall be 17016 Crawley Road, Odessa, Florida 33556.

**ARTICLE II
Purposes and Powers**

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

**ARTICLE III
Duration**

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The Company shall be perpetual unless earlier dissolved as provided in these Articles of Organization.

**ARTICLE IV
Capital Contributions**

The members of the Company shall contribute to the capital of the Company the cash or property set forth as follows:

ARTICLE V
Admission of New Members

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE VI
Management by Members

The Company shall be managed by the members in accordance with the regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. Registered Office and Agent

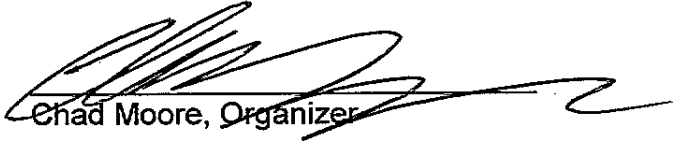

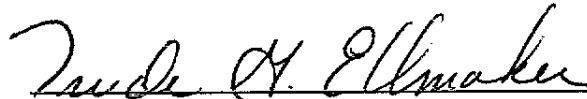

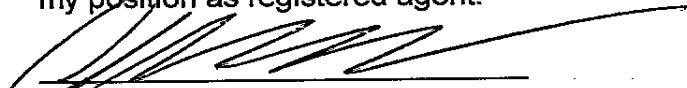
