ARTICLES OF ORGANIZATION OF IVDS/RLV, L.L.C.

ARTICLE I

Name

The name of the limited liability company ("Company") is IVDS/RLV, L.L.C.

ARTICLE II

Address

Duration

Admission of New Members

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which


terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.




