The name of this limited liability company shall be

ARTICLE IX - MEMBERS' RIGHT TO CONTINUE BUSINESS

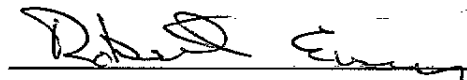

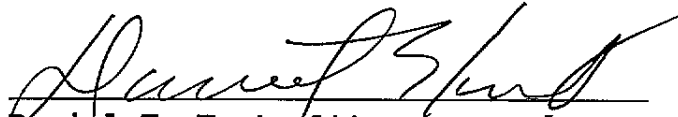

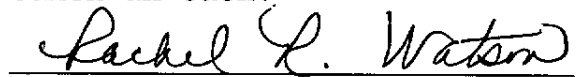
