SIGNET, L.C.,

**ARTICLE I  
NAME**

The name of the Limited Liability Company is:

**ARTICLE II  
PRINCIPAL ADDRESS**

**ARTICLE III  
DURATION**

The Limited Liability Company shall exist in perpetuity from the date of filing these Articles with the Department of State, unless otherwise dissolved.

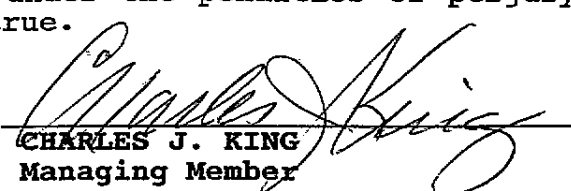
