**AMENDED AND RESTATED**  
**ARTICLES OF ORGANIZATION**

The Articles of Organization of Florida Cancer Specialists of Lee County, P.L., a Florida professional limited liability company (the "Company"), were filed with the Florida Department of State on April 6, 1998, and assigned document number L98000000430. Pursuant to the Certificate of Amendment to the Articles of Organization of the Company, filed with the Florida Department of State on January 11, 1999, the Company changed its name to Florida Cancer Specialists, P.L.

The Company now desires to (a) change its business purpose from rendering professional service to any and all lawful business purposes for which limited liability companies may be organized according to the laws of the state of Florida pursuant to Section 621.13(3), Florida Statutes; (b) be governed by the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes; and (c) amend and restate its Articles of Organization, as amended and in effect immediately prior to giving effect to the instrument.

Therefore, the Articles of Organization of the Company, as amended and in effect immediately prior to giving effect to the instrument, are hereby amended and restated to read in their entirety as follows:

**ARTICLE I**  
**NAME**

The name of the limited liability company shall be Florida Cancer Specialists & Research Institute, LLC (the "Company").

**ARTICLE II**
