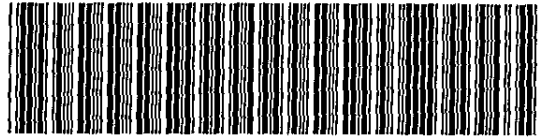



**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
HANBURY EVANS NEWILL VLATTAS
VALLADAREZ & COMPANY, L.C.**

FIRST: The name of the Company is Hanbury Evans Newill Vlattas Valladarez & Company, L.C. (the "Company").

SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on April 6, 1998, effective April 3, 1998.

THIRD: The Articles of Organization of the Company are hereby amended as follows:

Article I of the Articles of Organization is amended in its entirety to provide:


