**ARTICLES OF ORGANIZATION
OF

The undersigned hereby form and establish a limited liability company pursuant to Chapter 608, Florida Statutes as follows:

ARTICLE I

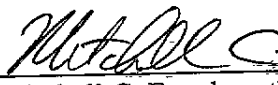

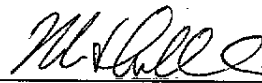

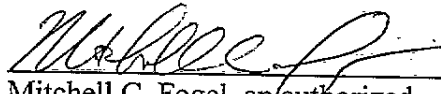
