ARTICLE I - NAME OF LIMITED LIABILITY COMPANY

The name of this limited liability company shall be SCHECK WATER WORKS, L.C.

ARTICLE II - PERIOD OF DURATION

The period of duration of this limited liability company shall commence on April 9, 1998 and shall continue until dissolved pursuant to Chapter 608 of the Florida Statutes.

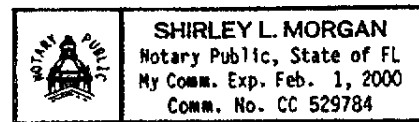
