

**ARTICLES OF ORGANIZATION
OF
ALLIANCE INTEGRATED MANAGEMENT, L.C.
a Florida Limited Liability Company**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be ALLIANCE INTEGRATED MANAGEMENT, L.C. ("Company").

ARTICLE V - ADMISSION OF NEW MEMBERS

ARTICLE IX - ADDITIONAL CAPITAL CONTRIBUTIONS


Each member shall make additional capital contributions to the company only on the unanimous consent of all the members.
