**ARTICLES OF ORGANIZATION  
of

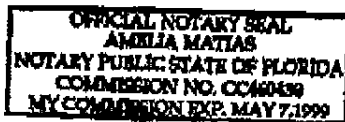

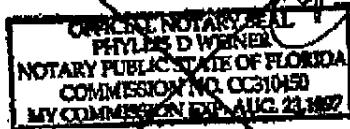

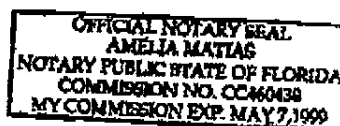
