**ARTICLE I
NAME**

The name of the limited liability company (hereinafter "Company") is CHARDEL 4, L.C.

**ARTICLE II
ADDRESS**

**ARTICLE III
DURATION**

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed with the Florida Department of State.

**ARTICLE IV

**ARTICLE VI
ADMISSION OF NEW MEMBERS**

Members of the company have the right to admit new members. Additional members may be admitted on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time new members are admitted.


ARTICLE VII

The power to adopt, alter, amend or repeal the regulations of the Company is vested entirely in the manager of the Company.

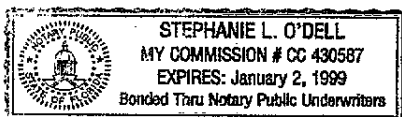
