## ARTICLES OF ORGANIZATION OF

# RENAISSANCE ENTERTAINMENT PRODUCTIONS, LLC A Florida Limited Liability Company

DIVISION 29 PH 2: 28

The undersigned, being desirous of forming a limited liability company pursuant to Chapter 608, Florida Statutes, hereby certifies as follows:

- 1. Name of Limited Liability Company. The name of the limited liability company is **RENAISSANCE ENTERTAINMENT PRODUCTIONS, LLC**, a Florida limited liability company (the "Company").
- 2. <u>Period of Duration</u>. The latest date on which the Company is to dissolve is December 31, 2025.
- 3. <u>Principal Office</u>. The mailing address and street address of the principal office of the Company shall be 1419 E. Amelia Street, Orlando, Florida 32803.
- 4. Agent for Service of Process: Address of Registered Agent. The initial agent of the Company for service of process shall be Jerry C. Bryant, 431 E. Central Boulevard, Suite 603, Orlando, Florida 32803.
- 5. <u>Right to Admit Additional Members</u>. The members shall have the right to admit additional members only with the consent of all members.
- 6. Right to Continue Business of the Company. Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the Company (a "Withdrawal Event"), the Company shall be dissolved and its affairs wound up, unless the business of the Company is continued by the consent of members owning more than 50% of the membership interests in the Company, with such consent being given within ninety (90) days after the Withdrawal Event.
- 7. <u>Member Management</u>. The Company shall be managed by a manager or managers and the initial two managers of the Company who are to serve as managers until the first annual meeting of members or until their successors are elected and qualified are as follows:
