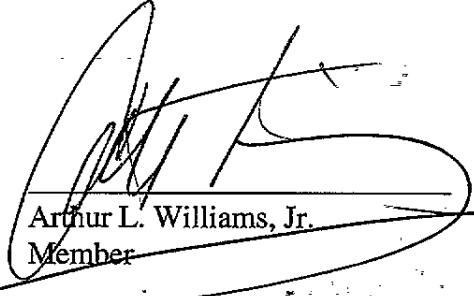
(3) Article I of the Articles of Organization of this limited liability company is amended to read as follows:

"ARTICLE I"

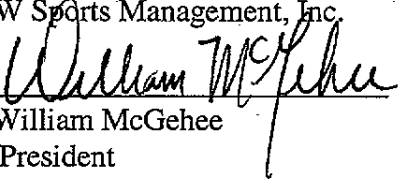
