ARTICLE I

NAME

The name of this limited liability company shall be HILLTOP LITTLE, L.C. and its principal place of business shall be located at 1030 West International Speedway Blvd., Daytona Beach, FL 32114, and the mailing address shall be the same.

COMMENCEMENT OF CORPORATE EXISTENCE

HEADINGS AND CAPTIONS

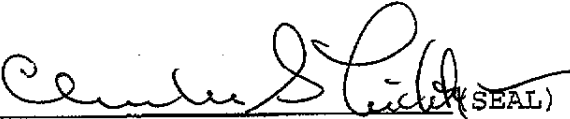
