The addition of new members shall require the unanimous consent of the members.

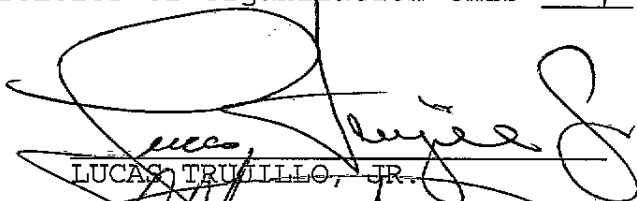
ARTICLE VI

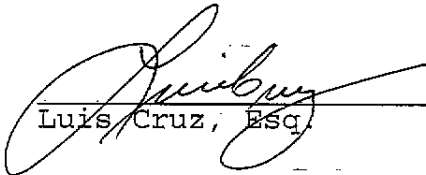

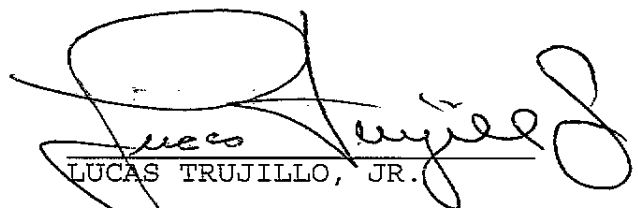
