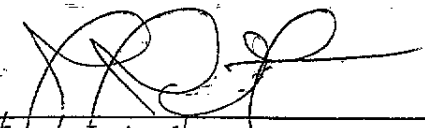

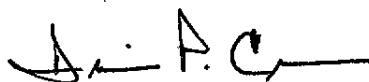

JAMES J. ARADO, being duly sworn, deposes and says that:

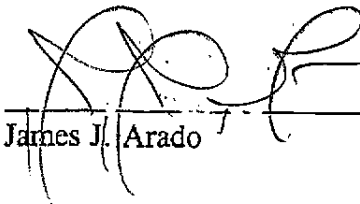

2. I declare that the above named limited liability company has at least two members.

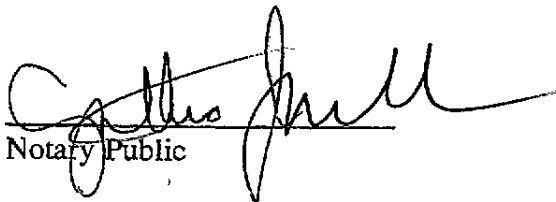

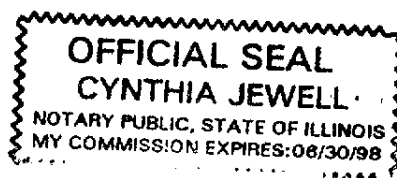
