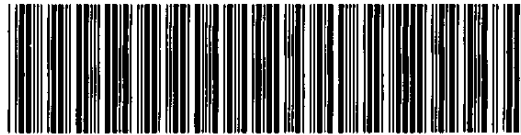

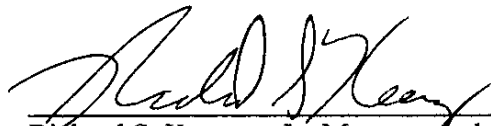

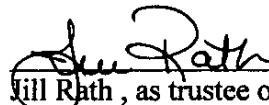

RESOLVED: All remaining property and assets, if any, will be distributed among the members in accordance with their respective right and interests.



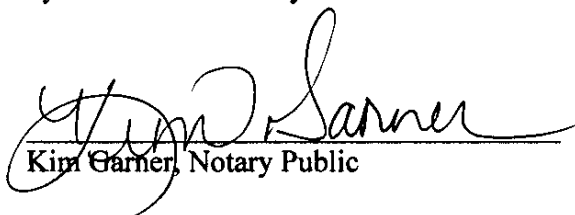

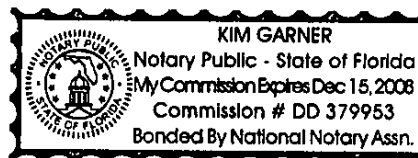
