

ARTICLES OF ORGANIZATION OF BIG TREE NOVA, LC

ARTICLE I

NAME

The name of this limited liability company shall be BIG TREE NOVA, LC, and its principal place of business shall be located at 1030 West International Speedway Blvd., Daytona Beach, FL 32114, and the mailing address shall be the same.

ARTICLE II

COMMENCEMENT OF CORPORATE EXISTENCE

This Company shall exist for a period of thirty (30) years commencing on the date of filing of these Articles of Organization with the Secretary of State of Florida unless sooner dissolved according to law.

ARTICLE III

GENERAL PURPOSE: GENERAL POWERS

The general purpose of this Corporation shall be the transaction of any and all lawful business. This Corporation shall have all of the powers enumerated in the Florida Limited Liability Company Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law.

The management or conduct of the business and affairs of the Company shall be vested in a Board of Managers as provided in the regulations of the Company. This Company shall have one (1) Manager initially. The number of Managers may be increased from time to time by the regulations of the Company. This Company reserves the right to amend or repeal any provisions contained in these Articles of Organization, or any amendment hereto, and any right conferred upon the Members is subject to this reservation.

ARTICLE XI

HEADINGS AND CAPTIONS

The headings or captions of these various Articles of Organization are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various Articles shall not be influenced by any of said headings or captions.
