ARTICLES OF ORGANIZATION OF 54 LITTLE, LC

ARTICLE I

NAME

The name of this limited liability company shall be 54 LITTLE, LC, and its principal place of business shall be located at 1030 West International Speedway Blvd., Daytona Beach, FL 32114, and the mailing address shall be the same.

ARTICLE II

COMMENCEMENT OF CORPORATE EXISTENCE
