ARTICLES OF ORGANIZATION OF C 500-35, L.L.C.

ARTICLE I - Name

The name of the Limited Liability Company is C 500-35, L.L.C. (the "Company").



ARTICLE II - Address

The mailing address and street address of the principal office of the Company is 3725 Leafy Way, Coconut Grove, Florida 33133.

ARTICLE III - Duration

ARTICLE VI - Members Rights to Continue Business

The right, if given, of the remaining members of the Company to continue the business in the event of the termination of the Company due to death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining or surviving members June continue in the business of the Company provided that not less than a majority of the ownership interests agree to do so in writing
