**ARTICLES OF ORGANIZATION
OF
WALL STREET DIRECT, L.C.**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

ARTICLE I
Name

The name of the Limited Liability Company is: Wall Street Direct, L.C.

ARTICLE II
Address of Place of Business

The street address and mailing address of the principal office in Florida for the Limited Liability Company is: 10228 Northwest 63rd Drive, Parkland, FL 33076.

ARTICLE III
Purpose

The purpose for which the Limited Liability Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Limited Liability Company shall have all of the powers vested in a Limited Liability organized and existing by virtue of such laws.

ARTICLE IV
Period of Duration

This Limited Liability Company shall exist until 30 years from the date upon which these Articles of Organization are filed with the Department of State of the State of Florida, unless earlier terminated by the terms of this Article IV. 
