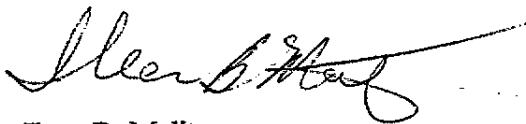
The partners have no place of business in the State of Florida. There are no suits pending against the company and all debts will be transferred to the general partnership.

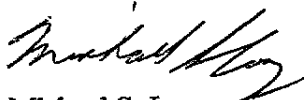
