ARTICLES OF DISSOLUTION  
FOR  
A FLORIDA LIMITED LIABILITY COMPANY

FIRST: The name of the Corporation is High Net Investors, LLC (the "Company").

SECOND: The effective date of the Company's dissolution is December 31, 1998.

FIFTH: All remaining property and assets have been distributed among its members in accordance with their respective rights and interests.


SIXTH: There are no suits pending against the Company in any court.
