**ARTICLES OF ORGANIZATION

**FIRST:** The name of this limited liability company shall be Open MRI of Indian River L.C. (the "Limited Liability Company").

**SECOND:** The period of duration for the Limited Liability Company shall be perpetual unless sooner dissolved in accordance with the laws of the State of Florida.

**THIRD:** The mailing and street address of the principal office of the Limited Liability Company shall be 2 Starfish Drive, Vero Beach, Florida 32960.

**FOURTH:** The name of the initial registered agent of the Limited Liability Company, shall be Philip M. Sprinkle II, Esquire. 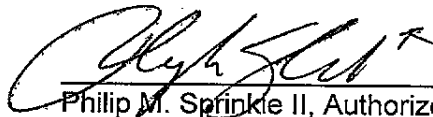

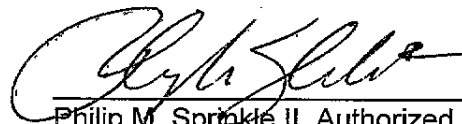

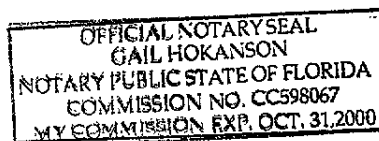
