**AMENDED & RESTATED ARTICLES OF ORGANIZATION**

**THIS AMENDMENT AND RESTATEMENT OF ARTICLES OF ORGANIZATION OF LYNDELL CITRUS & CATTLE, LLC (the "Company"), is made this 6<sup>th</sup> day of June, 2000.**

**WHEREAS**, the Company filed duly executed Articles of Organization with the State of Florida on July 15, 1998, with an effective date of July 17, 1998 (Document No. L98000001142).

**WHEREAS**, the Company has been continuously in effect since July 17, 1998, and will continue to be effective as restated as amended pursuant to the terms and provisions of this instrument.

**NOW, THEREFORE**, pursuant to the right of amendment set forth in Section 608.411 of the Florida Statutes, the Company hereby amends the Articles of Organization by deleting Articles I through VIII in their entirety and substituting the following in lieu thereof, as a complete restatement of the Articles of Organization:
