The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I – NAME**

The name of the limited liability company shall be D & S OF CORAL SPRINGS, L.C. ("Company").

**ARTICLE II – ADDRESS**

The mailing address and street address of the principal office of the Company shall be 2750 Stickney Point Road, Suite 201, Sarasota, Florida 34231.


