## ARTICLES OF ORGANIZATION FOR LM REED ENTERPRISES, L.C.

## A FLORIDA LIMITED LIABILITY COMPANY

The undersigned (the "Member") acting as the organizer and the sole Member of LM REED ENTERPRISES, L.C., under the Florida Limited Liability Company Act, Chapter 608, <u>Fla. Stat.</u>, adopts the following Articles of Organization:

#### ARTICLE I NAME

The name of the limited liability company is LM REED ENTERPRISES, L.C.

## ARTICLE II PURPOSE AND POWERS

A. <u>Purposes</u>. The Company is organized for any legal and lawful purpose for which limited liability company may be organized pursuant to Chapter 608, <u>Fla. Stat.</u>, as the same may be amended from time to time.

B. <u>Powers</u>. The Company shall have and may exercise all powers and rights which a limited liability company may exercise pursuant to Chapter 608, <u>Fla. Stat.</u>, as the same may be amended from time to time.

### ARTICLE IV DURATION

The Company's existence shall commence upon the acceptance of these Articles of Organization by the Secretary of State, and it shall exist perpetually thereafter unless dissolved according to law. Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of any Member, or upon the occurrence of any other event which terminates the continued membership of any Member in the Company, continued by the unanimous written consent of all the remaining Members, the Company shall dissolve.

## ARTICLE V MANAGEMENT

The management and control of the Company and its business and affairs is reserved to the Members of the Company. The managing member of the Company with exclusive authority tempanage the business of the Company shall be:

The Company shall admit new Members only upon the unanimous written consent of all then existing Members of the Company. Any new Members admitted shall not become Managing Members without the unanimous written consent of all then existing Members of the Company.

# ARTICLE VII MEMBERS RIGHTS TO CONTINUE BUSINESS

The right of the remaining Members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the limited liability company shall be upon the unanimous written consent of all then existing Members of the Company.

## ARTICLE VIII AMENDMENTS

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the unanimous written approval of all Members of the Company.




