ARTICLE SIX: SUITS PENDING

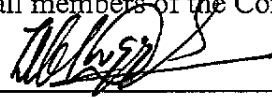

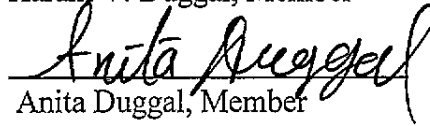

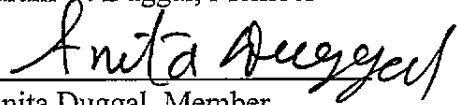
