**ARTICLE I


**ARTICLE VI**

**MEMBERS RIGHT TO CONTINUE BUSINESS**

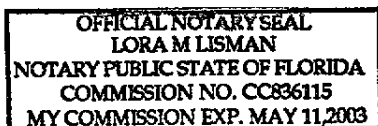



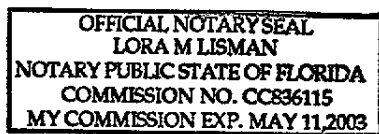
