THESE ARTICLES OF ORGANIZATION are entered into this 30th day of July, 1998, and are effective as of the date of filing with the Secretary of State of Florida.

1. The name of the limited liability company shall be Spraker, Fitzgerald & Tamayo, L.L.C. (the "Company").

2. The term of existence of the Company shall commence with the filing of these Articles of Incorporation with the Secretary of State of the State of Florida, and shall continue until December 31, 2100, unless sooner dissolved pursuant to the Regulations, Articles, or by operation of law.

5. New Members shall be admitted only with the unanimous consent of, and upon terms unanimously approved by, the Members.

6. In the event of the death, retirement, resignation, expulsion, withdrawal, bankruptcy or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued on approval of all of the remaining Members (other than the terminated Member and its successors-in-interest).

7. The management of the Company shall be reserved to the Members, the names and addresses of which are as follows:

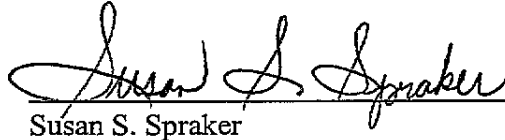

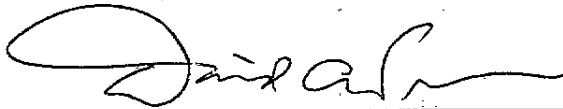
