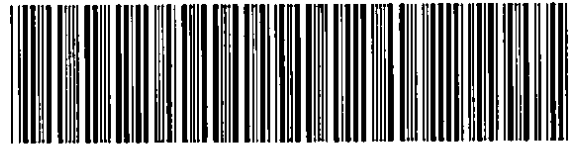

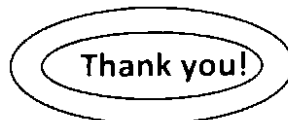

**Articles of Conversion
