ARTICLES OF ORGANIZATION

Pursuant to the provisions of Section 608.411 of the Florida Statutes, **FLORIDA NEIGHBORHOOD CENTERS LLC**, a Florida limited liability company (hereinafter, the "Limited Liability Company") adopts the following Certificate of Amendment to its Articles of Organization:

**FIRST:** The name of the Limited Liability Company is: **FLORIDA NEIGHBORHOOD CENTERS LLC**.

**SECOND:** The date of filing of the Articles of Organization was August 5, 1998.

**THIRD:** The following amendment to the Articles of Organization was adopted by unanimous consent of the members and sole manager of the Limited Liability Company on September 25, 2001.

**FOURTH:** Article IX, Section B of the Limited Liability Company's Articles of Organization is hereby amended to read in its entirety as follows:

"B. incur any indebtedness or assume or guaranty any indebtedness of any other entity, other than the first mortgage and the second mortgage given by the Company to the Lender and indebtedness permitted therein and debt incurred in the ordinary course of business;
