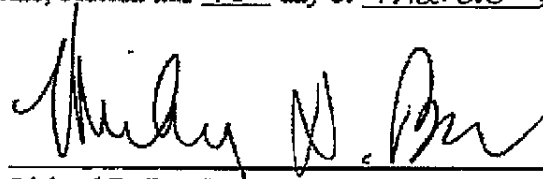

1. The name of the Limited Liability Company is LBA Financial Planning Partners, LLC, a Florida limited liability company.
2. The Articles of Organization were filed with the Department of State on August 5, 1998.
