
ARTICLE VI





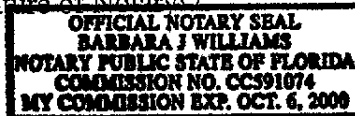
