FOR

ARTICLE I - NAME

The name of this limited liability company shall be **SI SILVER & SONS, L.C.**



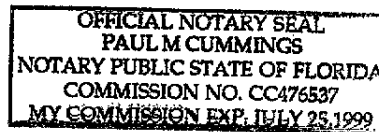
