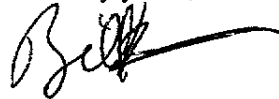

The right, if given, of the remaining members to admit additional members and the terms and conditions of the admissions shall be with the affirmative vote of all Members.

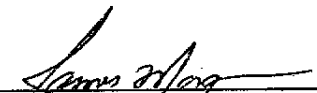
ARTICLE VI - Members Rights to Continue Business:

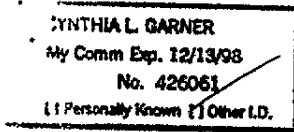
