
Hector Garcia and Gerardo Aguirre organizing members of the limited company no longer individually occupy management positions.

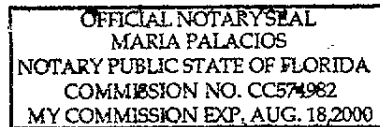
