**CERTIFICATE OF AMENDMENT
TO ARTICLES OF ORGANIZATION
OF
PODS, LLC**

The undersigned being one of the members named in the Articles of Organization of PODS, LLC, a Florida limited liability company, (the "Company"), in accordance with the provisions of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is PODS, LLC
2. The Articles of Organization for the Company were filed with the Florida Department of State on August 27, 1998 and a Certificate of Amendment to Articles of Organization for the Company was filed with the Florida Department of State on February 9, 1999.
3. Article I of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

**"ARTICLE I.
NAME**

"The name of the Limited Liability Company shall be PODS USA, LLC".

4. This Certificate of Amendment Shall be effective upon filing with the Florida Department of State.
5. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.

The execution of this Certificate of Amendment of the Articles of Organization by the undersigned constitutes an affirmation under the penalties of perjury that the facts stated herein are true and correct.
