ARTICLE I

Name

The name of this Limited Liability Company shall be **APOLLO BEACH CENTER, L.C.**

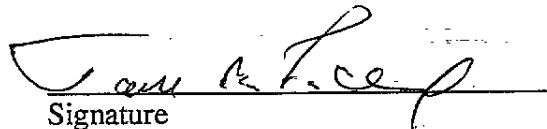

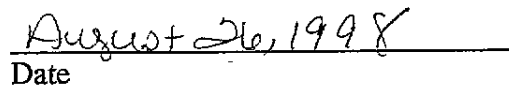

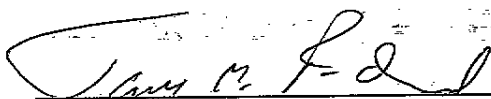
