The undersigned subscribes to these Articles of Organization to form a limited liability company under the Florida Limited Liability Company Act.

## ARTICLE

The name of this limited liability company shall be VIZCAYA LAKES APARTMENTS II, L.L.C.

#### ARTICLE II

The purpose for which this limited liability company has been organized is:

- 1. To own, hold, sell, assign, transfer, operate, lease, mortgage, pledge or otherwise deal with that certain real property, together with all improvements located thereon, known as "VIZCAYA LAKES APARTMENTS II" located in Ocoee, Orange County, Florida.
