The undersigned hereby organizes a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes (the "Act"), and adopts the following Articles of Organization.

ARTICLE 1.
NAME.

The name of the limited liability company is "TAZUNI, L. L. C." (the "Company").

ARTICLE 2.
ADDRESS.

The mailing address and street address of the Company's principal office is 5708 4th Avenue NW, Bradenton, Florida 34209.

ARTICLE 3.
DURATION.

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed with the Florida Department of State.

ARTICLE 4.
INITIAL REGISTERED AGENT AND OFFICE.

The street address of the Company's initial registered office is 5708 4th Avenue NW, Bradenton, Florida 34209. The name of the Company's initial registered agent at such office is Frans Coppers. The registered office and registered agent may be changed from time to time by the Members as authorized by law.

ARTICLE 5.
MANAGEMENT.

The management of the Company is reserved to its Members. The Company shall be managed in accordance with the Regulations adopted by the Members. The name and address of the Initial Managing Member is as follows: Frans Coppers, 5708 4th Avenue NW, Bradenton, Florida 34209.

ARTICLE 6.
ADMISSION OF NEW MEMBERS.

Additional Members of the Company may be admitted, but only upon the written consent of not less than a majority of all then current Members, or such greater number as may be

specified by the Regulations. Unless otherwise provided in the Regulations, an assignee may become a Member with the consent of Members having a majority in interest, determined by relative capital accounts.

**ARTICLE 7.
CONTINUATION OF COMPANY.**

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company, the Company shall be dissolved, unless the majority of the remaining Members, or such other number as may be required by the Regulations, consent in writing to continue the business.


**ARTICLE 8.
REGULATIONS.**

The Members shall have the power to adopt, alter, amend or repeal Regulations of the Company containing provisions for the regulation and management of the affairs of the Company.

**ARTICLE 9.
POWERS.**

The Company shall have all of the rights and powers now or hereafter conferred on professional limited liability companies by the Laws of Florida.

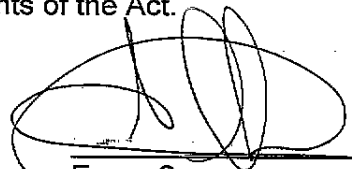

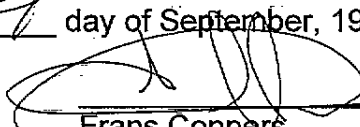
