

ARTICLES OF ORGANIZATION
OF

Article I

Name

The name of the Limited Liability Company is Paritas Truck Lines, L.L.C. (the "Company").

Member in this Company by the sale of new Interests for such consideration as the Members by their unanimous votes shall determine, or (ii) become a Substitute Member as a transferee of a Member's Interest or any portion thereof in the manner prescribed by Article XI of the Company's Operating Agreement.

Article VI


Members Rights to Continue Business
