ARTICLES OF ORGANIZATION OF DAWS FOREST PRODUCTS, L.L.C.

The undersigned, H.C. DAWS, a natural person competent to contract, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, Florida Statutes.

ARTICLE I

The name of the limited liability company is: DAWS FOREST PRODUCTS, L.L.C.

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing address and street address of the principal office of the limited liability company is Ellyson Industrial Park,

ARTICLE III - PURPOSES AND POWERS
