**ARTICLES OF ORGANIZATION OF
DAWS FOREST PRODUCTS, L.L.C.**

The undersigned, H.C. DAWS, a natural person competent to contract, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, Florida Statutes.

ARTICLE I

The name of the limited liability company is:
