**CERTIFICATE OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION

FIRST: The date of filing of the articles of organization was August 31, 1998.

SECOND: The following amendments to the articles of organization were adopted by the limited liability company to be effective as of April 12, 1999.

Article I is hereby deleted and the following is substituted therefor:

**ARTICLE I. NAME**

The following shall be added as articles to the Articles of Organization.
