ARTICLES OF ORGANIZATION of UNITY ADJUSTMENTS, L.L.C.

The undersigned certify that we have associated offselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.
